Survey of major themes in human thought processes, concept formation, problem solving, creativity, language use and cognitive development.

- To be able to recognize and explain how both bottom-up and top-down processing contribute to a variety of different cognitive processes including perception, attention, and memory.
- -To make predictions based on theory and interpret the meaning of data that has been collected in relation to that theory.
- -To be able to make connections between findings in psychology and their implications for real world settings such as education, law, and medicine.
